IV. PUBLIC COMMUNICATIONS: Members of the public are allowed 3 minutes to address any item pertaining to the CCP, but not on the Agenda.

Sheriff-Coroner Jim Hart announced that the Women's Recovery and Reentry Program (WRRP) will be a model site for the nation. The WRRP is a gender specific program intended to improve the safety, functioning and quality of life of female offenders through reduced substance use and recidivism.

V. ORAL REPORTS AND ACTION ITEMS

1 Probation Initiatives and Updates: Fernando Giraldo

Chief Giraldo shared that the Reducing Revocations Challenge is in Phase II of the three-year project in partnership with RDA Consulting. Phase II is the pilot program in which clients are incentivized to come to the office, without fear that if they have a positive UA, they might be arrested. If the clients show up clean, they will receive a gift card. The pilot began in September and the response from clients has been positive.

Probation was awarded the Mobile Probation Services Grant to purchase two Sprinter vans to increase accessibility throughout the county and provide mobile services to those who cannot readily access probation offices and/or services.

2. Report on CAFES Cohort II and Cohort III Programs (Proposition 47): Sarah Fletcher

Division Director Sarah Fletcher shared that CAFES Cohort II wrapped up the direct client services component in December 2022, and the data has been submitted data to BSCC. Probation will share the results when they are made public.

Cohort III has helped support the Public Defender's new advocate team and continued expansion of neighborhood court, as well as the services started through Cohort II.

BASTA Operations Team:

• Decided as a collaborative to not meet during June and July. Monthly meetings will resume once school year starts in August.

BASTA Intervention Group (BIG)

- Providing case management services, and mentorship to youth, their friends, siblings and family members as appropriate
- Family engagement and support.
- Prevention and early intervention services for youth including but not limited to:
 - o Youth experiencing substance abuse needs and mental health issues
 - o Youth with credit deficiency that could benefit from academic support
 - Youth with high levels of truancy during the school year that coils benefit from case management over the summer months
 - Youth at risk of gang involvement and/or participation
 - Diversion/ intervention and formal probation as appropriate to complete probation/ diversion terms successfully.

- Met with students and families over the summer break to reduce learning loss, increase credit recovery via summer school and increase pro-social activities for youth.
- Provided youth with case management and information regarding employment, community-based resources and services, and long and short-term career and educational planning.
- Met with community, educational, and law enforcement partners regarding youth well-being, family support, and plans for their next academic year.
- Many youth sought support regarding resumes, job interviews, and opportunities for community service hours and stayed connected with BASTA staff over the summer.
- Family members received support regarding activities for their child/ children and safe locations that youth can go. Also, family members received information regarding services and resources available and referrals as needed over the summer and in preparation for the next school year.

It has been a great summer. Many youth are looking forward to next school year and, where appropriate, students have transitioned to schools that may serve them better regarding credit recovery and accrual. Santa Cruz County Probation officers, Sheriffs, and Police were supportive and available to answer questions, address concerns and brainstorm next school year regarding best practices, community safety, youth well being, family engagement and collaboration into the future. Our students and families continued to see success over the summer, and we are identifying strategies to close gaps and serve those most in need moving forward.



Written Report from Standing Committees and Task Force Report Date: <u>July 18th, 2023</u>

Committee/Task Force Name: Youth Action Network (formerly Youth Violence Prevention Network)

Activities since the last CJC Meeting aligned with CJC Purpose:

Youth Participatory Action Research (Y-PAR) Session Updates:

- May Session #8: The May Y-PAR session revolved around focus groups and analyzing survey data. Youth learned to compare survey data based on the demographic of survey respondents and learned how to read different types of graphs. At this time youth had collected around 700 survey responses.
- June Session #9: During June, youth who participated in Y-PAR had the opportunity to provide their feedback during our in-person and virtual listening sessions. We learned that overall, they felt the activities were engaging and believed the topics we discussed are very important and pertain to our communities. Youth found it insightful learning about the challenges our community is facing and felt a sense of accomplishment after collecting and analyzing survey data.

Capitola City Youth Partnership:

• Youth Action Network has been supporting the Capitola City Youth Partnership. Agencies involved include: United Way, Capitola City Council, Capitola Police Dept., Cradle to Career, Capitola Mall, Santa Cruz County Office of Education, and Lookout Santa Cruz. The goals of the collaborative include: 1) Co-create solutions with youth to support positive behavior and youth wellbeing; 2) Shift from problematic youth behavior to positive healthy youth behavior; 3) Create a sense of safety & belonging at the Capitola Mall & Village for all. The group is organizing an event at the Capitola Mall & working to transform the Capitola Mall Police Department space at the Mall into a Youth Resource Hub. YAN created an online youth input survey; hosted a listening session with Live Oak youth & has been doing outreach to other young people to get them involved in the project.

Sign Up For Our Newsletter: Stay up to date with Youth Action Network programming, events, and surveys by signing up for our newsletter! During the month of August we will begin recruitment for our new YAN Steering Committee. This committee will be composed of up to 15 high school youth from throughout Santa Cruz County. Youth will have the opportunity to work on projects that will apply to their community and the entire county. Our August newsletter will share more information on recruitment and Fall opportunities.
