1. Community Corrections Partnership -

Fernando Giraldo mentioned CCP may be rating treatment options. He said the sobering center is diverting about 200 cases a month from jail and more funding is needed for medical treatment. He also said that SB823 closed youth division and is working on creating our own security/treatment facility for youth. Eli Chance mentioned that Rising Scholars received a grant and is working with probation and County Office of Education. They have already worked with two students.

2. Santa Cruz County Anti-Crime Team –

Adriana Flores mentioned they are working with federal and state partners but are unable to disclose anything at this time. She said SCCACT has collected close to 100 firearms already this year. She also said SCCACT has taken part in various summer youth academies.

Isabele came to Dr. Small's office at age 25 with large keloid scars on her upper chest and shoulders.


Isabele explained it was difficult as a woman to have visible scars especially on the chest and that it diminished her confidence. Before the scars, she had been a swimmer but she stopped wearing a bathing suit because of them and discontinued swimming all together.

Isabele told us that she felt embarrassed when she'd gone to other providers because they had been taken aback by the size and severity of the scars, and so, for over 10 years she had not sought care for her scars and instead kept them hidden and always covered.

Her experience with Dr. Small has been different. She said Dr. Small was "great because she understands, is caring and makes me feel comfortable. She is also confident, calm, listens and she knew what was going on with my skin right away and how to treat it and made a treatment plan for me."

Isabele has had 3-4 Kenalog injections and has seen progress she never thought possible. She is reassured to know there are effective treatments for her skin condition. Her confidence is growing, she is feeling better about herself, and is looking forward to starting back up with activities.

She is grateful to SCO because "it's a great cause and a great mission."



# DR. REBECCA SMALL

Dr. Small's commitment to service and supporting the underserved is reflected by her long history of volunteer activities in our community. She has been a dedicated volunteer as the sole female physician for over 15 years at Dominican Hospital's Youth Delinquency Tattoo Removal Program helping at-risk youth. She served as a member of the Dominican Hospital Foundation to raise funds for the hospital, and her long-term contributions to Sienna House and our local chapter of 100+ Women underscore her dedication to positive change and improving the lives of women in need.

During the challenging times in the COVID-19 pandemic, Dr. Small expanded her practice to offer complimentary primary care and urgent care services to patients. In addition, she re-privileged at Dominican to be available as back-up medical staff and ensure our local hospital was ready to respond to any critical medical emergencies,

# ABOUT DR. SMALL

Dr. Small is a graduate of Harvard Medical School and Associate Clinical Professor at UCSF School of Medicine who specializes in outpatient aesthetic procedures. She is an educator and recognized authority in the field of aesthetic medicine, having taught at UCSF for 15 years, led national conferences, and published medical textbooks.

Her passion for education shines through in her mentoring at UCSC for high school students interested in medicine, and at Natividad Medical Center, where she has volunteered to teach family medicine residents from Salinas at her practice since 2008. This year, she continues her mentorship with the new Dominican Hospital

Family Medicine Residency.

She has always had a focus on women's health issues and advocacy for women. At Harvard, Dr. Small co-founded and led a student advocacy group for faculty diversity that ultimately established a tenured Dean position tasked with the promotion and advancement of women, and received the Special Award of Recognition from the American Medical Women's Association for this activity.

Establishing her own non-profit 501(c)(3) has been a long-term dream for Dr. Small. Skin Care Outreach was created to serve local women and adolescents who have facial or visible scaring and markings due to trauma or negative life experiences (e.g., abuse, inadequate access to care, cancer, illness). Our intention is to help rebuild confidence and self-esteem by performing aesthetic treatments for those who are unable to afford these procedures, thereby helping them to reintegrate into the community and workforce, and overcome their experiences of trauma, violence or illness.

# GOALS

## RECRUITMENT

Identify individuals from underserved populations with dermatologic and aesthetic concerns that impair their ability to obtain a job or adversely impact their self-esteem (see attached list of organizations we are seeking to recruit from).

## SERVICE DONATION

Dr. Small will generously provide her services and will train other providers to provide these services as well.

## TARGET CANDIDATES

We aim to support survivors of domestic violence, victims of crimes and trafficking, individuals with traumatic injuries, cancer patients, survivors of car accidents, individuals subjected to forced tattooing, among others, who face financial hardships and cannot afford aesthetic care.

## TYPES OF SERVICES

Our services include laser treatments, keloid injections, tattoo removal, aesthetic injectables like dermal fillers and botulinum toxin, and more.

## **EXAMPLE OF CASES**

We address a range of concerns such as scars, burns, low self-esteem due to facial marks, wrinkles, asymmetry, visible tattoos, birthmarks, and more.

# FACIAL SCARING

## TYPICAL CASES:

Domestic violence survivors seeking to reenter the workforce.

Victims of violent crimes left with facial scars.





# FACIAL REJUVENATION

## TYPICAL CASES:

Survivors of trauma seeking to reintegrate into the community—addressing concerns such as facial volume loss and asymmetry.


Cancer or other serious illness survivors that have boney prominences, sunken eyes or temporal wasting.












# TATTOO REMOVAL

Santa Cruz County Undersheriff Chris Clark shared that the Sheriff's Office had received a grant of over \$1 million to fund the In-Custody MAT program; however, it was rescinded due to state budget cuts. He made a one-time request of \$200,000 in bridge funding from the CCP to support in-custody MAT while the Sheriff's Office secures ongoing funding for the program.

Written Report from Standing Committees and Taskforces Report Date: November 07, 2024

Committee/Task Force Name: Youth Action Network (formerly Youth Violence Prevention Network)

Activities since last CJC Meeting aligned with CJC Purpose:

#### Youth and Adult Partnerships (YAP) Summit 2024

The first YAP Summit, held on June 12th at Cabrillo College, showcased the YAP survey findings and emphasized best practices for youth engagement. Attended by 60 adult leaders and nine youth presenters, the summit offered actionable tools, feedback forms, and theory of change models to encourage organizations to embed youth voices in their work. The YAP Summit content is informing how agencies engage youth throughout the County



#### Santa Cruz City and Capitola City Youth Liaisons

United Way's Youth Action Network is collaborating with the cities of Santa Cruz and Capitola to establish formal Youth Liaison roles, where selected high school students engage directly with local government representatives and City Commissions. Over 20 high school students applied for the position, indicating a need for more opportunities for youth to engage with decision-makers. In the end, 4 youth high schoolers were selected to serve Santa Cruz City, and 2 were selected to serve Capitola City. This role provides essential youth feedback on city matters and allows youth to have a say in local governance. Both cities are committed to adopting United Way's *Working with Youth Policies and Guiding Principles for Working with Youth*, frameworks informed by our UC Santa Cruz partners to promote meaningful and ethical youth involvement.







#### **Youth Participatory Action Research**

Our next round of Youth Participatory Action Research (YPAR), in collaboration with UC Santa Cruz, launched its first session on October 19th, with a total of 14 youth participants and 9 UCSC undergraduates. This new 3 year cycle of YPAR engages youth



leaders from four programs—Friday Night Live, County Office of Education's Youth-Led Leadership Alliance, Jóvenes Sanos, and YAN's Youth Liaisons—in the topic of youth voice and participation. By partnering with the coordinators from each program, we're building a network of youth leaders committed to advocating for increased participation in policy conversations. Together, this group of youth leaders will collaborate on research initiatives and community projects that give young people a stronger voice and presence in shaping the future of Santa Cruz County.

#### **October Youth Action Network Convening**

On October 24th, the Youth Action Network (YAN) convened with community partners to explore our latest data on Youth and Adult Partnerships. The session highlighted the newly developed Spotlight Page on DataShare, created in collaboration with Eva Holt-Rusmore, who also provided attendees with an in-depth platform tutorial. Additionally, we reviewed findings from the Youth Adult Partnership (YAP) Survey, analyzed by UC Santa Cruz, allowing for meaningful discussions on strengthening youth-adult relationships in our community.
